 - Terhune: The amendment is to facilitate two MPO projects that are ready to begin immediately. These projects are included as agenda items for the 8/1/19 Technical Committee Meeting. The extra funds in the personnel line item are due to personnel changes within the MPO that have left unused funds.

- 3. Resolution FY20-02: Use of \$25,000 from FY19 UPWP-Professional Services, for Catlin Transportation Study.
 - McLain: Distributed material describing the issues which would be covered by the study. Fehr Graham Engineering would investigate the potential for constructing an overpass over the NS railway, replacing the at-grade crossing at either Paris or Sandusky Streets.
 - Nelson: Will this project require a public participation component and is Catlin required to submit an RFP for the work to be done?

 - Trygg: RFP's are not required for projects under \$40,000.
 - Nelson: Requested that a public meeting be included as a component of the transportation study. And motioned that the Resolution be amended to include the Transportation Study Description in both the FY19 and FY20 UPWP's.
